

FAD TOOLS INTERNATIONAL, LLC LICENSE AGREEMENT

This is an agreement between the Licensee and FAD Tools International, LLC., the authorized EPRI Licensee of FAD Tools Software. By using this software Licensee agrees to be bound by the terms of this agreement. FAD Tools International LLC., grants to the Licensee, a nonexclusive right to use this copy of the FAD Tools Software only for Licensee's internal business purposes. The Licensee does not possess any right to sublicense the software to any affiliate or other third party. Any attempt by Licensee to sublicense any portion of the FAD Tools software, without specific written authorization from FAD Tools International, LLC is a material breach of this license Agreement and is cause for FAD Tools International, LLC to terminate this Agreement. If any provision of this License Agreement is found to be invalid, illegal or unenforceable, the validity, legality and enforceability of any of the remaining provisions of this agreement shall remain in effect and FAD Tools shall create an enforceable provision of similar intent and economic impact to replace any unenforceable provision. This agreement shall be governed by the laws of the Commonwealth of Pennsylvania.
